

# WELCOME

ECKA is a not-for-profit, Early Years Manager, providing management services for Kindergartens, Long Day Care and Occasional Care Centres in the Ballarat and surrounding area.

The Victorian Government developed the Early Years Management system to achieve improved outcomes for all young children through the delivery of world class, accessible early childhood education and care services.

ECKA services are provided by dedicated early childhood professionals who are supported to adopt contemporary evidence-based practices to enhance children's learning. All ECKA staff are supported on a day to day basis and provided with many opportunities to undertake professional development to continuously improve their skills.

ECKA is licensed by the Department of Education and Training (DET) to operate this children's service, and as such are responsible for ensuring compliance with National and State Government licensing requirements. The majority of early childhood services managed by ECKA provide State Government funded kindergarten programs for children in the two years before they attend school.

ECKA's purpose, Enriching children's lives through learning, can only be achieved where children are in education and care environments that are safe, welcoming and inclusive for children and their families; and ensure that children's health safety and wellbeing is protected at all times. Importantly, children must not only be safe but also feel safe. The welfare of children in ECKA services is at all times our priority and ECKA has a zero tolerance to child abuse.

ECKA operates under a range of legislative, policy and procedural requirements that prioritise the safety of children as paramount at all times, and these are available on the ECKA website, ECKA office, and ECKA Services

ECKA encourages all children, families, employees and others involved with ECKA services to participate in regular evaluation and review of policies and practices, or at any time provide feedback, anonymously if desired, via the ECKA website, ECKA office or ECKA service. At all times, any complaints or concerns about child safety will be treated with the highest priority.

#### **Statement of Commitment**

ECKA:

- is committed to the rights of all children to feel safe, and be safe at all times, including:
  - o promoting the cultural safety of Aboriginal children
  - promoting the cultural safety of children from culturally and linguistically diverse backgrounds
  - o promoting the safety of children with a disability
  - promoting the safety of trans and gender diverse children and their families in ECEC settings
  - o ensuring that LGBTIQ+ children and families feel included
- values, respects and cares for children
- empowers children's voices by fostering opportunities for each child to participate, express their views, and to learn and develop
- always acts in the best interests of each child and has zero tolerance of child abuse
- takes all reasonable steps to ensure the health, safety and wellbeing of children at all times, whilst also promoting their learning and development

- proactively sharing information with relevant authorities to promote the wellbeing and/or safety of a child or a group of children, consistent with their best interests

# EARLY YEARS MANAGEMENT

## **Eligibility Criteria for Funded Kindergarten**

The Victorian State Government provides funding for each eligible child attending a funded 3 & 4 year old kindergarten program in the two years prior to starting school. Please note that children cannot attend more than one funded kindergarten program in the same year. If children require a second year of funded 4 year old kindergarten they need to meet the criteria set by Department of Education and Training (DET).

To be eligible for funded 3 year old kinder your child/ren must: turn 3 years old on or before the 30 April in the year they will be attending kindergarten.

**To be eligible for funded 4 year old kinder your child/ren must:** turn 4 years old on or before the 30 April in the year they will be attending kindergarten, or be eligible for Early Start Kindergarten, or have received funding for a second year of 4 year old kindergarten through a criteria set by the DET or be approved for any other funding requirement set out by the DET.

Early Start Kindergarten (two years of funded kindergarten): Research shows that for vulnerable and disadvantaged children, earlier enrolment in quality education and care improves their learning and development outcomes.

**To be eligible for Early Start Kindergarten your child/ren must:** Turn 3 years old on or before 30 April in the year they will attend, and be identified as being Aboriginal and/or Torres Strait Islander; or be known to child protection, be a refugee or asylum seeker.

Please speak to the Teacher at your kindergarten or the ECKA administration staff if you require further information about Early Start Kindergarten.

## **Employment of Staff**

ECKA is the employer of the Educators (teachers and co-educators) at all ECKA member services. ECKA employs a CEO, Administration staff and Early Education Advisory Teachers to assist all services. ECKA is required to meet all requirements under the appropriate Awards and Occupation Health and Safety Laws. Teaching Staff at all early childhood education services are required, and supported by ECKA, to have a continuing professional development plan, and access to quality professional development training.



## **Policies**

Early childhood education services managed by ECKA are governed by a number of policies that cover such issues as Child Safe Environment and Wellbeing Fees- including Free Kindergarten, Collection and Delivery of Children, Enrolment, Parental Access, Privacy of information, Sun Protection, Inclusion of Children with Additional Needs (including information regarding support funding available from the government) and many others. ## <u>Fees</u>

ECKA have opted in to participate in Free Kinder, which is part of the Victorian Government Best Start, Best Life reform will help all Victorian children dream even bigger through increased access to quality early childhood education and care. A critical part of the reform is Free Kindergarten, which will support access to two years of high-quality kindergarten programs for all Victorian children. All families with a child enrolled in a funded kindergarten program are eligible for Free Kindergarten, this includes both 3 and 4-year-old kindergarten programs.

Free Kindergarten supports families to access a funded kindergarten program by:

- providing a free 15-hour program to four-year-old children enrolled at a sessional service
- providing a free 5-to-15-hour program to three-year-old children enrolled at a sessional service (subject to the length of funded program offered)
- offsetting the funded kindergarten program component of parent fees for three and four-yearold children enrolled at a long day care service

Free kindergarten supports every Victorian child to get the best start in life no matter where they live. Research shows that play-based learning is a powerful way to support children's learning and development. Two years of early learning is a crucial part of their educational journey, these benefits last into the school years and beyond.

Parents accessing Long Day Care at Beaufort Early Childhood Centre or Occasional Care at Trentham Early Learning Centre are responsible to register for childcare subsidy through Centrelink for long day care programs and gap fees will be calculated based on eligibility. Long day care bookings forms will outline the daily fees and are available from the ECKA office.

# **EDUCATIONAL & RECREATIONAL PROGRAM**

ECKA Educators have high expectations for all children. Each child is viewed as a competent and capable learner and the Educator acknowledges that children learn at different rates and times and in many different ways. Programs at ECKA early childhood education services follow the guiding principles and outcomes of the Victorian Early Years Learning and Development Framework and The Early Years Learning Framework for Australia as required by the National Quality Framework.

The program provided involves the Educator's pedagogical understanding of how children's interests and strengths are built upon using a play-based curriculum. Planning of the educational program involves the integration of child-directed play and learning; guided play and learning; and adult led learning.

#### **Early Years Learning and Development Outcomes**

Outcome 1: **IDENTITY** Children have a strong sense of identity - Children feel safe, secure and supported.

In order to form a strong sense of self, children need to build secure relationships first within the family and then with caring, attentive adults in other settings.

Outcome 2: COMMUNITY Children are connected with and contribute to their world -Children develop a sense of belonging to groups and communities and an understanding of the reciprocal rights and responsibilities necessary for active civic participation.

Over time and with opportunity and support, the ways in which children connect and participate with others increase. Participating in their communities strengthens children's sense of identity and wellbeing.

Outcome 3: WELLBEING Children have a strong sense of wellbeing - Children become strong in their social, emotional and spiritual wellbeing.

During early childhood, the foundations for social, emotional and spiritual wellbeing are laid.

Outcome 4: **LEARNING** Children are confident and involved learners - Children develop dispositions for learning such as curiosity, cooperation, confidence, creativity, commitment, enthusiasm, persistence, imagination and reflexivity.

Outcome 5: COMMUNICATION Children are effective communicators, Children interact verbally and non-verbally with others for a range of purposes.

# NATIONAL QUALITY FRAMEWORK

The National Quality Framework (NQF) was the result of an agreement between all Australian governments to work together to provide better educational and developmental outcomes for children. The NQF includes the National Law and Regulations, National Quality Standards, an Assessment and quality rating process and the Learning frameworks - Victorian Early Years Learning and Development Framework and The Early Years Learning Framework.

The National Quality Framework is overseen by the *Australian Children's Education and Care Quality Authority* (ACECQA)

## **Benefits for children and Families**

Research shows quality education and care early in life leads to better health, educational and employment outcomes later in life. The early years are critical for establishing self-esteem, resilience, healthy growth and capacity to learn. Quality education and care shapes every child's future and lays the foundation for development and learning.

## National Quality Standard

- 1. Educational program and practice
- 2. Children's health and safety
- 3. Physical environment
- 4. Staffing arrangements
- 5. Relationships with children
- 6. Collaborative partnerships with families and communities
- 7. Governance and Leadership

#### **National Quality Rating and Assessment Process**

ECKA early childhood education and care services will be assessed and rated against each of the seven Quality Areas of the National Quality Standard and the National Regulations. They will also be given an overall rating. The rating and assessment process aims to drive continuous quality improvement at services and provide families with better information for making choices about their children's education and care. Early childhood experts and professionals maintain that quality is critical when it comes to early childhood education and care.

# **PRIVACY POLICY COLLECTION STATEMENT**

We believe your privacy is important. Eureka Community Kindergarten Association Inc. (ECKA) has developed a *Privacy and Confidentiality Policy* that illustrates how we collect, use, disclose, manage and transfer personal information, including health information. This policy is available on request.

To ensure ongoing funding and licensing, our service is required to comply with the requirements of privacy legislation in relation to the collection and use of personal information. If we need to collect health information, our procedures are subject to the *Health Records Act 2001*.

The Child Information and Family Violence Information Sharing Scheme allows Early Childhood Services to freely request and share relevant information with Information Sharing Entities to support a child or group of children's wellbeing and safety when the threshold test has been met

#### Purpose for which information is collected:

The reasons for which we generally collect personal information are given in the table below.

Personal information and health information collected in relation to:	Primary purpose for which information will be used:
Children and parents/guardians	To enable us to provide for the education and care of the child attending the service To manage and administer the service as required
The Approved Provider if an individual, or members of the Committee of Management/Board if the Approved Provider is an organisation	For the management of the service To comply with relevant legislation requirements
Job applicants, employees, contractors, volunteers	To assess and (if necessary) to engage employees, contractors, volunteers or students
and students	To administer the individual's employment, contracts or placement of students and volunteers

Please note that under relevant privacy legislation, other uses and disclosures of personal information may be permitted, as set out in that legislation.

Disclosure of personal information, including health information:

Some personal information, including health information, held about an individual may be disclosed to: government departments or agencies, as part of our legal and funding obligations; local government authorities, for planning purposes; organisations providing services related to employee entitlements and employment; insurance providers, in relation to specific claims or for obtaining cover; law enforcement agencies; health organisations and/or families in circumstances where the person requires urgent medical assistance and is incapable of giving permission; anyone to whom the individual authorises us to disclose information; information sharing entities to support a child and group of children's wellbeing and safety.

Laws that require us to collect specific information:

The Education and Care Services National Law Act 2010 and the Education and Care Services National Regulations 2011, Associations Incorporation Reform Act 2012 (Vic) and employment-related laws and agreements require us to collect specific information about individuals from time-to-time. Failure to provide the required information could affect:

- a child's enrolment at the service
- a person's employment with the service
- the ability to function as an incorporated association.

# Kindergarten information sharing

#### Information for families with children enrolled in a funded kindergarten program

Department of Education

Each year, kindergarten providers collect information about the families and children enrolled at their services. This includes sessional kindergarten and long day care services that offer a kindergarten program. This information is shared with the Department of Education (the department) if your child is enrolled in a funded kindergarten program.

## How the department uses your information

The department uses your information to:

- confirm how much funding to pay to your kindergarten service to deliver the kindergarten program.
- plan any changes to funding and supports for services and families and help local councils plan their early childhood services.
- link kindergarten information with other Victorian Government information to help plan and deliver supports for Victorians. Data linkage is done in a safe way to so that your child's name is **not** linked to the enrolment information used for analysis.
- complete the Annual Kindergarten Census. Some enrolment and attendance information is shared with the Australian Bureau of Statistics so that it can report on the numbers of children attending kindergarten in Australia each year. This information is anonymous, meaning your child's name is **not** shared.
- help approved academic researchers study the childcare or kindergarten system in Victoria. If research is approved, researchers have limited access to anonymous information.

Any agency or researcher, whether it's the Australian Bureau of Statistics, or a researcher at a university, must meet strict criteria on how they use and store this information, even when it's anonymous.

## Information sharing and Free Kinder

Occasionally, data needs to be shared without making it anonymous.

In Victoria, Free Kinder will be available from 2023. Many children receive Free Kinder through their long day care service. Accessing Free Kinder means that those families will have their long day care out-of-pocket fees reduced.

To do this, the Australian Government requires that some information about those children is shared with them including a child's name, gender and Free Kinder funding amount received from the Victorian Government.

If you receive the Child Care Subsidy (CCS), the Australian Government already has most of that information. Sharing this information with the Australian Government lets them know that your child is attending a state-funded kindergarten program.

The department must also share information that is not anonymous where required by law.

#### **Privacy policies**

All information is handled in accordance with the Department of Education's <u>Privacy Policy</u> and relevant privacy legislation including the *Privacy* and *Data Protection Act* 2014 (*Vic*) and the *Health Records Act* 2001.

## Access to Information

Individuals about whom we hold personal, sensitive or health information can gain access to this information in accordance with applicable legislation. The procedure for doing this is set out in ECKA's Privacy and Confidentiality Policy, which is available on request. For information on the Privacy and Confidentiality Policy, please refer to the copy available at the service or contact the ECKA Administration Office on 5339 5055.

#### **Photographs and Videos**

Photographs and videos are classified as 'personal information' under the *Privacy and Data Protection Act 2014*.

The purpose of the permission form that you have signed is to:

- comply with the privacy legislation in relation to all photographs/videos taken at the service, whether by the Approved Provider, Nominated Supervisor, Person in day-to-day charge, educators, staff, parents/guardians, volunteers or students on placement
- enable photographs/videos of children to be taken as part of the program delivered by the service, whether group photos, videos or photos at special events and excursions etc.
- Notify parents/guardians as to who will be permitted to take photographs/videos, where these will be taken and how they will be used.

## Photographs/Videos taken by staff

Staff at the service may take photographs/videos of children as part of the program. These may be displayed at the service, on the Eureka Community Kindergarten Association Inc. (ECKA) website or placed in the service's publications or promotional material to promote the service, or for any other purpose aligned to the service's business operations. Some staff may use learning journals, or private communication programs such Storypark, in which photographs are included.

During the kindergarten year the devices that photographs or videos are recorded on, including camera memory cards, computers and electronic devices will be stored securely with password access where applicable.

When the photographs/videos are no longer being used, the service will destroy them if they are no longer required, or otherwise store them securely at the service. It is important to note that while the service can nominate the use and disposal of photographs they organise, the service has no control over those photographs taken by parents/guardians of children attending the service program or activity.

Parents should not include photos of staff, other parents, or children other than their own, on social networking websites such as FACEBOOK or Instagram without the permission of other parents or staff.

# SUMMARY OF DELIVERY AND COLLECTION OF CHILDREN POLICY

## Kindergarten Sessions

Kindergarten programs have scheduled hours of attendance. Parents/guardians are responsible for supervising their own child/ren before signing them into the program and after they have signed them out of the program. Supervision of your child/ren will become the teacher's responsibility after the child is signed in on the attendance record at the beginning of the session.

Early delivery of your child to kindergarten may be negotiated in certain circumstances, please speak to your teacher if this is applicable to you.

## Sign In / Out; all services

Please note that when your child/children are signed in and out of the kinder session and / or childcare, the actual time that the child arrives or is collected must be recorded.

## Late Collection from Kindergarten

Children must be collected from services on time.

Late collection of children impacts on the ability of the staff to complete their non-contact duties in the kindergarten programs. A late fee may be charged by ECKA to cover the extra time that staff are required to work in such circumstances.

It is often distressing to children to have to wait for their parent/guardian when all other children have been collected. A full copy of the Delivery and Collection of Children Policy can be found at the kindergarten on the ECKA website.

#### Parents/Guardians are Responsible for:

- Completing and signing the authorized nominee section of your child's enrolment form before your child attends the service
- Signing and dating permission forms for excursions
- Proving written authorisation where children require medication to be administered by educators/staff, and signing and dating it for inclusion in your child's medication record
- Ensuring Educators are aware that their child has arrived at/been collected from the service
- Supervising other children in their care, including siblings, while attending or assisting at the service



# FAMILY INVOLVEMENT

Family contribution to your child's education and care is very important to us and your child. There are many different ways that families may contribute in and out of kindergarten sessions. Some of the activities in the kindergarten session may include; attending an excursion, helping the children plant in our vegetable garden, cutting up the shared fruit platter or coming in to read a story, or out of session by supporting social events and providing your feedback and ideas.

If you are interested in volunteering some time to help, please speak directly with the educators or message them via the Storypark app. We understand that people have busy lives and lots of commitments and if you are not able to indicate support right now, we completely understand, however if your circumstances change, please feel free to speak with educators as they will be happy for your help.

Please note that our parent volunteers do not need a working with children's check provided that the volunteering is in the group with your own child. Staff will fully supervise all volunteers in accordance with our volunteer and visitor policies.

Please check with your service as to the current opportunities for involvement. Opportunities for involvement include (but are not limited to):

- Participating in your child's program
  - speak to you child's teacher on how to become involved
- Participating in Parents and Friends Activity Groups

   information is provided at the start of the year
- Providing feedback on Policy Development and Review
  - see the parent notice board, ECKA website or Story Park
- Participation in the Quality Improvement Plan
  - speak to your child's teacher and regularly view the parent notice board or posts on Story Park

#### Code of conduct for parents/guardians, students, volunteers, contractors and visitors

- acknowledges the vulnerability of Aboriginal children, children from a culturally and linguistically diverse background and children with a disability and has zero tolerance of discrimination
- maintains a duty of care (refer to Definitions) towards all children at the service
- · is committed to the safety and wellbeing of each child at the service
- is committed to the safety and wellbeing of all staff at the service
- provides a safe and secure environment for all at the service
- provides an open, welcoming environment in which everyone's contribution is valued and respected
- is committed to communicating openly and honestly
- is committed to continually learning how to be inclusive and respectful of cultural needs
- encourages parents/guardians, volunteers, students and community members to support and participate in the program and activities of the service.

#### **Relationships with children**

In our relationships with children, I commit to:

- being a positive role model at all times
- encouraging children to express themselves and their opinions
- allowing children to undertake experiences that develop self-reliance and self-esteem
- maintaining a safe environment for children
- speaking to children in an encouraging and positive manner
- giving each child positive guidance and encouraging appropriate behaviour
- regarding all children equally, and with respect and dignity
- having regard to each child's cultural values
- respecting individual difference including age, physical and intellectual development, and catering for the abilities of each child at the service.

## A Note for Families

A healthy balance of the sun's ultra violet (UV) radiation exposure is important for health. Too much UV can cause sunburn, skin and eye damage and skin cancer. Over exposure to UV during childhood and adolescence is a major factor in future skin cancer risk. Too little UV from the sun can lead to low Vitamin D levels. Vitamin D is necessary for the development and maintenance of healthy bones and muscles, and for general health.

Our service aims to achieve a healthy UV exposure balance for children and staff. We are a registered member of the Cancer Council Victoria's SunSmart Program. Please help support our SunSmart membership by ensuring you child follows the SunSmart measures encouraged by Educators.

From September to April (and when UV levels reach 3 and above) use these 5 Sun Smart steps:
